Accounting	Bug	Fixed an issue that would cause EFT checks to be exported to QuickBooks with their check number instead of "EFT".
Agency Setup	New Feature	In Agency Setup > Settings, a new tab for Book of Business Sale allows administrators to export specific client/policy data for a partial Book of Business sale to a non-HawkSoft agency.
Agency Setup	Bug	Resolved issue with Merge Carrier when the carriers have the same NAIC with varying Company Numbers configured for the same State.
Agent Portal	Bug	Corrected an issue in Agent Portal that was causing all logs to display when looking at a policy vs just the policy logs.
Commissions	Enhancement	When viewing the Agent Paid Statements report, users can now drill down into each agent to see transaction details.
Commissions	Enhancement	When adding a new transaction, you can now add a policy number. If added, we will automatically search by that policy number and match the transaction if there is only one match.
Commissions	Enhancement	When reconciling a commission statement, clicking a commission transaction row will begin editing it now. If unmatched, clicking "unmatched" will begin the matching process.
Commissions	Enhancement	Updated the date picker when creating a manual commission transaction on a statement to be consistent with other date pickers found in tasks.
Downloads	Bug	Fixed issue causing the "Most Recent Download" link to launch the wrong download.
Reporting	Enhancement	Quick Reports for all clients/policies or active clients/policies may now be filtered by client or policy office.
Reporting	Enhancement	When running a report there is now a way to immediately download the report as CSV without viewing it in the browser. This is helpful for very large reports which are untenable to view in the browser.
Reporting	Enhancement	A new Quick Report for All Prospect or Lead Policies allows users to start a report with only these policies, saving the steps of summarizing from a report of all policies.
Tasks	Enhancement	Effective, Status, and Expiration Dates are now available columns that may be added to the Task Center, which assists agencies in prioritizing tasks based on policy dates. While viewing a task associated with a policy, you can now also see these dates along with policy number and client CSR.

Text Messaging	Enhancement	Added the ability to delete texting conversations if you have the textine administrator permission. Note: This will delete all incoming and outgoing texts for the phone number in the conversation you delete, regardless of what client it is on.
Batch Email	Enhancement	When restarting CMS if a Batch Email was paused, the Batch Emailer will start again.
